1. New by-laws

In 2021 we revised our by-laws, as the one we had dated from before the committee on comparative gender studies had become a standing research committee of the ICLA and didn't reflect its reality anymore. Also, we wanted to clarify election procedures (see Article 6). For this, the procedures described in Articles 8 and 13 were followed. Following an online committee meeting in the Fall of 2021, and discussion through email about the proposed new by-laws, these were eventually submitted to the EC for approval, which was granted in Spring of 2022.

2. Elected Officers

Officers serve a three-year term with the option to serve only one additional term of three years if they so choose. In 2022, several terms of office expire. Elections for new officers are organized following the procedure described in the by-laws.
